### **Palantir and Microsoft Expand Cloud Partnership to Public Sector**

April 5, 2023 -- Palantir Technologies Inc. announced that Palantir Federal Cloud Service (PFCS) achieved FedRAMP authorization and accreditation to support workloads at U.S. Department of Defense (DoD) Impact Level (IL) 4 and DOD IL5 on Microsoft Azure. This new milestone enables U.S. government customers and industry partners to access Palantir and Microsoft's secure, integrated, enterprise-grade capabilities in both Microsoft Azure Government and Azure Commercial environments.

This milestone expands Palantir and Microsoft's strategic partnership from the private sector to the public sector bringing the best in class cloud components to the federal marketplace. We're aiming to support IL6 through multi-cloud service integration.

In addition to supporting public sector and DoD customers, the Palantir Federal Cloud Service (PFCS) was also designed for the greater Defense Industrial Base. PFCS on Azure Government meets Defense Federal Acquisition Regulation Supplement (DFARS) requirements and can support both Controlled Unclassified Information (CUI) and International Traffic in Arms Regulations (ITAR) workloads.

### **Palantir Awarded Australian Transaction Reports and Analysis Centre (AUSTRAC) Renewal to Support Financial Criminal Investigations**

MAR 23, 2023 -- Palantir Technologies Inc. announced that the Australian Transaction Reports and Analysis Centre (AUSTRAC) renewed its partnership for the ongoing delivery of an intelligence data analysis platform to support the AUSTRAC mission of protecting Australia's financial system from criminal abuse.

Since 2017, Palantir has partnered with AUSTRAC to optimise their use of financial data in support of criminal investigations. AUSTRAC builds resilience in the financial system and uses financial intelligence and regulation to disrupt money laundering, terrorism financing, and other serious crime.

AUSTRAC utilizes Palantir Technologies' Gotham and Foundry software platforms to integrate and fuse large scale data across their enterprise, driving decisions and operational outcomes.

### **Department of State Selects Palantir to Modernize Data Management for the Bureau of Medical Services**

March 8, 2023 -- Palantir Technologies Inc. announced that it has been selected by the Department of State to provide the Bureau of Medical Services (MED) with a platform for effective data management and data-driven decision-making. This competitively awarded BPA contract is worth \$99.6 million over five years.

Palantir software will be used by MED to establish a new enterprise data management platform for the department, titled Project Axiom. With MED's mission to advance the health, safety, and readiness of State Department personnel, Axiom will provide the Bureau with a common operational picture to better protect the diplomatic workforce and their families through data-informed decision-making. More specifically, the platform will help improve the Bureau's ability to react swiftly to global crises by enabling workflows related to emergency management and preparedness, mission tracking and logistics, aviation operations, and medical support.

As part of the Department of State's broader digital modernization efforts, this project will provide MED with a new set of tools and capabilities to safeguard and promote the health and well-being of America's diplomatic community. Axiom is at the core of a digital transition to enhance the delivery of proactive and efficient medical support to chief of mission personnel following a crisis, natural, or man-made disaster. This health-focused, enterprise-wide data integration and analytics platform will enable Bureau and Department leadership to make rapid decisions that reduce risk to mission and safeguard and promote the health and well-being of America's diplomatic community.
